Roles and Responsibilities of CUGAA:

- The founding members may be entrusted with the **responsibility of the formulation of rules and regulation of CUGAA** and also **the registration of CUGAA (as both under the Trust and Society Registration Act)**.
- The above mentioned founding members would register CUGAA as its permanent Trustees.
- The founding members also shall be the first managing council of CUGAA and further within eighteen months after the registration of CUGAA, election would be held for the Office Bearers of CUGAA.
- The first office Bearers of CUGAA (i.e. President, Vice President; General Secretary and Treasure) would be elected from amongst the founding members by the founding members themselves. Within eighteen months after the registration of CUGAA, elections

for the office bearers of CUGAA would be conduct as per the rules and regulations of CUGAA.

- The rules and regulations prepared by the founding members shall be submitted to the University authorities, for further approval, before it is taken up for registration.
- The Convener of the founding members of CUGAA shall be authorized to call meetings of CUGAA and take decisions in consultation with founding members for the formation of CUGAA.

And other terms and conditions will be as stipulated in the Ordinance No. 22 mentioned at reference-2 above.
