Notification regarding MoU of Central University of Gujarat with Apollo Hospitals International Ltd.

Central University of Gujarat, Gandhinagar has entered into an agreement with Apollo Hospitals International Ltd., Gandhinagar with effect from 23rd December, 2015 for providing medical facilities to its permanent employees and their dependents (who are declared dependents as per service records).

The terms and conditions for availing medical facilities are as under:-

1. The medical facility/treatment under this MoU shall be available only to "employees and their dependents" of Central University of Gujarat.
2. The patient/person accompanying the patient will produce the identity card and Authorization/recommendation letter issued by the University for verification by the Apollo Hospital.
3. The list of persons authorized by the University to issue an Authorization/Recommendation letter to Apollo Hospital is given below. In normal course University Consultant Doctor- Dr. Bhupendra B. Shah (Faculty Block, Sector 30, Central University of Gujarat, Gandhinagar, Mob. 9427022077) will issue the authorization letter. In case of emergency, the persons authorized to issue the authorization letter are as under:-

4. Apollo Hospital will provide required treatment after verifying I-Card/Authorization letter issued by the University.
5. Apollo Hospital will provide all the facilities as per the package rates agreed for various procedures, investigations, etc. on CGHS rate modified from time to time as applicable to NABH accredited hospitals at Ahmedabad-Gandhinagar and as per terms and conditions applicable to CGHS beneficiaries working in Central University of Gujarat, Gandhinagar
6. Apollo Hospital will provide all the services on cash payment basis to the outpatients **and on credit basis in the case of inpatient** treatments to “employees and their dependents” duly referred by the competent authority as defined above.
7. Apollo Hospital shall provide services for which it has been empaneled by CGHS at the rates fixed by the CGHS from time to time. In case any treatment/investigation or procedure CGHS-NABH rate is not found, reasonable charge to be amicably agreed i.e. **10% lesser than the existing tariff of Apollo Hospitals, Ahmedabad (excluding Medicine, Consumable, Blood product, Packages & outsourced investigation-treatment) will be charged.**
8. A copy of Discharge Slip incorporating brief history of the case diagnosis, details of procedure done, reports of investigation, and identification stickers of inpatient treatment given and advice shall be submitted by the Apollo Hospital along with the bill directly to the patient and a copy to the University.
9. Apollo Hospital agrees that any liability arising due to any default or negligence in providing or performance of the medical services shall be borne exclusively by the Apollo Hospital, who shall alone be responsible for the effect and/or deficiencies in rendering such services.
10. Apollo Hospital agrees that the out-patient treatment such as diagnosis, test, doctor’s fees will be as per CGHS NABH 2014 rates.
11. Apollo Hospital agrees that during the In-patient treatment of the CGHS beneficiary it will not ask the beneficiary or his attendant to purchase separately the medicines/consumables/equipment or accessories from outside and will provide the treatment within the package deal rate, fixed by the CGHS which includes the cost of all the items.
12. Apollo Hospital will honour permissions issued by the Referring Authority of Central University of Gujarat for their beneficiaries holding I-Card. Treatment will be provided as per prevalent/applicable CGHS NABH 2014 rates & **whenever CGHS change rate, the same will be applicable.**
13. Apollo Hospital will investigate/treat the Central University of Gujarat beneficiary patient only for the disease/condition/health check-up for which they are referred by “Authorised Medical Attendants” in the speciality and/or purpose for which they are approved by CGHS. In case of unforeseen emergencies of these patients during

admission for approved purpose/procedure, necessary life saving measures be taken and concerned authorities will be informed at the earliest opportunity with justification.

14. The duration of inpatient treatment for specialized and other procedures will be as per CGHS terms and conditions.

In case of emergency, or holidays, or Sundays or night hours, the Apollo Hospital will admit the patient upon necessity and based on the ID-Card. Recommendation Letter in such cases would be deposited with the Apollo Hospital on the next working day.
