After ascertaining the quorum required for the meeting, the Registrar started the meeting by welcoming all members of the Academic Council and requested the ICT team of university to recite the University Kulgeet. Thereafter, Hon'ble Vice Chancellor welcomed all the members and thanked them for making it possible to attend the 26th meeting of the Academic Council. Hon'ble Vice Chancellor then proceeded to recount a few seminal developments as well as the university's achievements since the last meeting of the Academic Council. He informed the House that subsequent to the sanction of funds by the Ministry of Education for the development of the permanent campus of the university at Kundhela, Vadodara, the university has held a series of meeting of the Building Committee and based on its recommendations, signed an MoU with CPWD for undertaking infrastructure projects. Later on, the university initiated the procedures, in conformity with the norms of Govt. of India, for hiring Consultant Architect and identified M/s. Planning Solutions, Vadodara for preparing structural design and lay-out of the permanent campus. The university also held a "Tree Plantation Ceremony" at the site which was graced by Dr. Hasmukh Adhia, Hon'ble Chancellor of the university.

Further, Hon'ble Vice Chancellor informed the House that the university had started operating in offline mode in view of the fact that the pandemic situation had eased up appreciably in the country, especially in Gujarat. The classes and practical sessions were being held in accordance with the protocols prescribed by the GoI and Covid-19 appropriate behaviour. Concomitantly, the university has initiated the procedures for admitting students in UG and PG programs through a national level test to be conducted National Testing Agency (NTS). Finally, in last six months, despite the pandemic constraints, the university has been throbbing with a variety of academic and research activities as well as events under the Govt. of India's flagship initiatives like *Ek Bharat Shrestha Bharat, Azadi ka Amrit Mahotsav* and so on. Such vibrant climate in the university has been instrumental in sustaining the zeal and enthusiasm of all

the stakeholders. Then, Hon'ble Vice Chancellor requested the Registrar to take up following agenda items for deliberation.

The considered the matter and approved the revised fee structure, consisting of both program fees and hostel fees, for implementation in AY 2021-22, subject to the condition that the revised fee structure would be applicable only to the freshly admitted students of the university and not the existing students.

# To consider and approve the registration of university students in various SWAYAM Courses for the Semester spanning July-December, 2021

**Resolution 17:**The Academic Council lauded the fact that the university students were opting for instruments of online learning like MOOCs which had been excellently put in place on various portals by the Ministry of Education and University Grants Commission. The Council considered the list of university students who had registered in various online courses available on SWAYAM portal for the semester spanning July-December, 2021 and unanimously approved it.

To consider and approve the amendments in existing Ordinance No. 02 & Ordinance No. 12 and draft amendment Statute-40 of the university.

**Resolution 18:**Hon'ble Vice Chancellor briefed the esteemed members that the Statutes and Ordinances Committee of the university had reviewed (1) Ordinance for Regulating Leave to Admissible to the Teachers of the University (2) Ordinance for the award of Degree of Philosophy and brought them in line with provisions of the latest, relevant UGC Regulations. Further, the university had constituted a committee to amend its existing Statue 40on "Schools and Centres in the University" in conformity with the provisions of CU Act, 2009 and its scheduled statutes. The House is perused the amended ordinances and statutes and unanimously approved them for further necessary action.

# To consider and approve the draft of new Ordinances prepared by the university

**Resolution 19:**Hon'ble Vice Chancellor informed the Academic Council that various Schools/Centres in the University wanted to offer cutting-edge Certificate / Diploma / Advance Diploma Programs. So, it was desirable that an ordinance in this regard was formulated. Further, he referred to the endowment proposals being received in the University for Institution of medals, memorial lectures and so on. To receive these endowments, the university had framed an ordinance under the statute 28(m) scheduled to CU Act, 2009. The Academic Council perused and considered the draft ordinances and unanimously approved them for further necessary action.

#### Item No. 20/26/AC/27.09.2021

To consider and approve the curricula of Compulsory Non-CGPA Courses on Holistic Education as prepared by Task Force Committee for implementation of NEP, 2020, to be offered to PG Students from AY 2021-22.

**Resolution 20:**Hon'ble Vice Chancellor informed the Council that in order to facilitate the implementation of NEP-2020, the university had constituted a Task Force Committee (TFC). The Committee had finalized the curricula of courses inculcating Holistic education, to be offered to the UG/PG students from AY 2021-22 in first and second semesters as compulsory, non-CGPA courses. The Academic Council scrutinized the curricula of the following papers.

Paper-1: Ethics, Human Values and Personality Development.
Paper-2: Indian Knowledge Traditions, Communication Skills and Yogic Practices.

After deep deliberation, the Council put on record its commendation for the initiative of the university and termed it the need of the times. The House then accorded a unanimous approval to the same.

### Item No. 21/26/AC/27.09.2021

To consider and approve the curricula of the courses on Multidisciplinary Education (Minor Elective Course of 02 Credits each) prepared by Task Force Committee for implementation of NEP, 2020 to be offered from AY 2021-22.

Resolution 21: Hon'ble Vice Chancellor informed the members' thatNational Education Policy-2020 laid immense stress on the importance of multidisciplinary education as a tool to afford diversity and vibrancy to the knowledge base of the students. Accordingly, the university had taken a decision to introduce 02-credit Minor Elective Courses from Academic Year 2021-22. Each School of the university had designed multidisciplinary minor elective course of 02 credits each consisting of a basic principles and premises of the specialization of the School. The Council perused the curricula of all such courses and unanimously approved them for offering in AY 2021-22.

# Item No. 22/26/AC/27.09.2021

To consider Minutes of Meeting of various School Boardsof the University.

**Resolution 22:** The Academic Council considered the Minutes of Meeting of various School Boards of the University and approved them. Further, the Council authorized Hon'ble Vice Chancellor to approve all such MoMs that are submitted at a later date.

# Item No. 23/26/AC/27.09.2021

To consider and approve the introduction of new programs and shifting programmes from School to Centre level and vice versa.

**Resolution 23:**Hon'ble Vice Chancellor informed the members that the university has been offering programs mainly at the level of Centre.

However, there were a few programs which were being offered at School level for some years now. This dichotomy created administrative issues and adversely affected multiple procedures including the inscription on the award of degree. For instance, the university degree mentioned the name of the Centre under which a degree for the specific program was awarded, something which was not possible under School-level program. Further, in view of the recommendation of the Committee constituted to look into the amendment in the Statute 40, the university had already prepared a draft of a new Ordinance governing the "Departments under Schools of Studies" and circulated it to all Deans for amendment in nomenclatures of existing Centres under their respective Schools, if required. In order to bring about uniformity in degrees for all programs offered at the university, an exercise of standardization had been initiated whereby all programs of the university were required to be brought under the existing Centres.

The Academic Council deliberated over the matter and unanimously resolved that all programs of the university should be offered under Centre/Department. Further, it resolved that the proposed new programs being introduced from AY 2021-22as well as any other School-level program already on offer should be brought under a Centre/Department in which its coordinator is appointed. Further, the House resolved that in Schools where there are no Centres/Departments, they should be created through the above-mentioned ordinance which has already been circulated to Deans.

# To consider and approve the revision of syllabi of various programmes run by Schools/Centres.

**Resolution 24:** The Academic Council considered the revised syllabi of various programs run by Schools/Centres and approved them. Further, the Council authorized Hon'ble Vice Chancellor to approve all such program syllabi that are submitted at a later date.

# To consider the specializations as well as relevant and allied subjects for the post of Teaching Staff.

Resolution 25: Hon'ble Vice Chancellor informed the House that the Ministry of Education had directed all Central Universities to fill the vacant post of teaching staff on priority basis and the Central University of Gujarat was in the process of issuing recruitment notification shortly. In Deans' meeting dated 07/09/2021 vide Resolution No. (5), it was resolved that each School should specify specification as well as relevant allied disciplines for the purpose of faculty recruitment in their School/Centres. Accordingly, all Deans had furnished the specializations as well as relevant/allied disciplines vis-à-vis the vacant teaching posts in their respective Schools/Centres. Subsequently, the recommendations of Deans were vetted by a Committee was constituted by

Hon'ble Vice Chancellor. The Academic Council perused the report of the committee and unanimously approved it.
