The final selection for the post of Professional Assistant (Library) (UR-01) will be based on the following terms and conditions:

1. The University will conduct the Objective Type test (Screening Test) carrying 100 marks. The successful candidates who secured 50% marks in the paper will be called for a Descriptive type test in order of merit subject to a maximum ratio of 1:15. (As per Ordinance No. 13)
2. There will be no negative marking in the objective type test.
3. The candidates who secure 50% marks in Descriptive-type test shall be called for the skill test.
4. The marks allocated for the skill test will be 50 Marks and the minimum qualifying marks in the skill test shall be 25 Marks.
5. The merit list of the candidates shall be drawn based on the performance in Descriptive-type test only, subject to a qualifying skill test.
6. Resolution of Tie Cases:  
The tie will be resolved by the University as under:  
g) By Age of the candidate i.e. the candidate with older age will be given a preference.  
h) If the tie persists, then higher aggregate marks/grade/CGPA in the prescribed educational qualification in the Cadre Recruitment Rules of the University as amended from time to time for the respective posts will be the criteria to decide the preference.

**Paper-1: Objective type questions of 100 Marks with Duration of 02 Hours.**

- **General Knowledge:** General Awareness
- **Simple Arithmetic and Reasoning Ability:** Series, Number-System, Factoring, Multiplication, Division, work and time, time and distance, Odd one out, Profit & Loss, Ratio, Proportion & Percentage.
- **English Language:** Synonyms, Antonyms, Idioms, Sentence completion, Sentence rearrangement, Comprehension, Idioms, Grammar, Articles, Preposition etc.
