University has adopted UGC (Minimum Standards and procedure for Award of M.Phil./Ph.D. degree) Regulation 2022 in the Academic Council meeting held on 27.12.2022 vide resolution number 08/28/AC/27.12.2022.

Some schools/centres have recommended exemption from course work to students pursuing Ph.D. through their respective CASR. In accordance with the newly adopted UGC regulations 2022 on PhD, the issue was referred to the competent authority for further direction.

In this regard, the competent authority has approved, based on the committee's recommendation, that ***"The Exemption from Ph.D. Course work is to be given to Candidates who have already awarded M.Phil. degree only and admitted to the Ph.D. programme in the same discipline/subject after recommendation of the Concerned CASR."***

All schools/centres are requested to take note of the same and take necessary action.
